Mekke Nikko Kyodo Center Privacy Policy

Yachiyo Engineering Co., Ltd. (hereinafter referred to as "our company") has established the following privacy policy (hereinafter referred to as "this policy") regarding the handling of personal information (hereinafter referred to as "personal information") of users of this service (hereinafter referred to as "users") in various services (hereinafter referred to as "this service") provided by the Mekke Nikko Kyodo Center, which is managed and operated by our company as a designated manager. In addition, for matters not specified in this policy, our company will handle personal information in accordance with our personal information protection policy (<https://www.yachiyo-eng.co.jp/privacy/>).

1. Purpose of use of personal information

(1) Our company will use personal information provided by users in relation to this service within the scope of the following purposes of use.

- To accept applications for the Service, verify the identity of the applicant, calculate the usage fee, and conduct screening
- To enter into rental contracts and prepare rental receipts for the use of the Service
- To contact customers and respond to inquiries from customers regarding the use of the Service
- To inform them of updates, event and campaign information, and changes to the terms and conditions of the Service
- To report on the user's personal information as part of the fulfillment of obligations under the non-life insurance contract concluded by the Company in providing the Service
- To improve, plan, propose, or implement the Service in the future
- To request cooperation in customer satisfaction surveys, etc. regarding the Service
- To create statistical data regarding the use of the Service

(2) The Company may handle personal information for purposes other than those listed in (1) above, if the User agrees or if permitted by law.

2. Provision of personal information to third parties, etc.

(1) The Company will not provide personal data to third parties, except when the User agrees or permitted by law.

(2) When the Company entrusts all or part of the handling of personal information to a third party within the scope necessary to achieve the purpose of use, the Company may provide personal information to the entrusted party for the third party to carry out the said business. In this case, we will select businesses that we recognize as handling personal information appropriately, and in the outsourcing contract, we will stipulate safety control measures, confidentiality, conditions for re-entrustment, and other matters necessary for the appropriate handling of personal information, and will properly supervise the outsourcing parties.

3. Safety control measures, requests for disclosure of held personal data, etc.
